2) Enhance knowledge and understanding about conflicts of interest in order for teachers and personnel to be able to distinguish common interests

1) To be committed to human resource management and development in a systematic manner, with morality, participation and accountability.

2) Focus on a systematic budget management based on the principle of cost-effectiveness and accountability.

3) give priority to fair, equitable and non-discriminatory assignments


4) Enhance the environment that facilitates and supports the performance of government officials and staff to be efficient
